Homestay Agreement 2003

1. Four Corners Language Institute uses the services of licensed homestay companies which arrange the placement of students in appropriate homes.
2. A non-refundable Homestay Placement Fee is charged for this service, and must be enclosed with your application: \$250 per person (\$275 if you are 17 years of age or less). The Homestay Placement Fee also includes a pick up service from the Victoria International Airport if requested by the student.
3. The current homestay fee is \$700 per month (\$750 if you are 17 years of age or less), which includes a private room, three meals per day, and access to laundry facilities. The monthly fee may be paid directly to your host family. For stays of less than one month, fees are calculated as follows:

1 – 14 nights	\$35 / night
15 – 21 nights	\$30 / night
18 years or over	
1 month	\$700 / month
Additional nights after 1 month	\$25 / night
17 years or less	
1 month	\$750 / month
Additional nights after 1 month	\$30 / night

4. You must provide your host family with 30 days notice, in writing, if you plan to leave before your scheduled homestay finish date.
5. If you would like to extend your stay with your host family, please inform the school at least two weeks before your scheduled homestay finish date. There is no guarantee that your host family will be available to continue hosting you.

6. During your stay with a host family, you must agree to abide by any rules they may have, for example, rules about smoking, the use of alcohol, or the use of the telephone.
7. You will be responsible for your own transportation to and from the school and to any social activities.
8. If a problem develops during your stay with a family, Four Corners will make an appointment for you to speak with a coordinator from the respective homestay company. You may discuss the situation with the coordinator, who will, within reasonable standards, work with you and the family to attempt to resolve the issue.

RELEASE AND AGREEMENT: I agree that I will not hold Four Corners Language Institute or its homestay organizations responsible for any accidents, injuries, or incidents that may occur.

It is the responsibility of the signing parties to have read, translated, and understood the conditions of this agreement before signing the Homestay Application Form.
